1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Potti Sreeramulu Telugu University was established with the primary aim of preserving and propagating all areas of knowledge in the Telugu speaking world. This University was the product of a confluence of many institutions already working towards the promotion of Telugu culture. Thus, the Andhra Pradesh Sahitya Akademi, the Lalit Kala Akademi, the Academies of Music, Dance and Drama, the Telugu Bhasha Samiti and the International Telugu Centre which were already in existence as separate entities, were brought under one umbrella, i.e. Telugu University. This in itself makes it a unique institution since it needs to carry out all the activities of these erstwhile organizations without compromising on the standards of the university. The University was first established as Telugu Vijnana Peetham in 1984 and on 2nd December of 1985 it emerged as a State University. In the initial phase, the university had three campuses, i.e. Rajahmundry, Srisailam and Warangal and later, in the year 1997 Siddhendra Kalapeetham, a renowned traditional training centre, dating from the 15 century of Kuchipudi came into its fold. The significance of these four campuses is that they are situated in different regions of the State, on the one hand, i.e. Telangana, Coastal Andhra and Rayalaseema; on the other hand, the Rural, Tribal and Urban. The University is a State level institution offering academic affiliation to 15 Government Music colleges from all regions of the State. Telugu University was re-accredited with ‘B’ grade by NAAC in the year 2018.

Vision

The vision of this university is to preserve and rejuvenate Telugu culture in all spheres. This institution was established combining the existing institutions which were working for the glory of Telugu culture in various fields like music, dance, literature, painting and drama. The vision of this university was to make these areas of culture accessible to every aspiring youth through courses leading to degrees; and to preserve the glory of the bygone days of Telugu culture, History, language and literature through research and publications.

- The students this university seeks to serve are from all over the state, from the marginalized sections of rural and tribal backgrounds.
- This institution was established to cater to the propagation of Telugu language, literature, fine and performing arts. The main aim was to bring these cultural fields which were confined to the elite, ie. Classical dance, Carnatic music, Painting, Sculpture, Theatre to the grass root level. Hence, it envisaged many courses like degree, P.G, certificate, diploma, P.G diploma and kalapravesika for the convenience of the students hailing from different backgrounds.
- This is a Language University with a unique nature. It is established with a vision to preserve, promote, uphold, and upgrade Language, Culture, History, Literature and Arts of the Telugu people.

Mission

To empower students in different fields through courses in basic and advanced studies in art, culture, music, drama, dance, painting, sculpture, architecture, history, language, literature, linguistics and journalism.

1. To function as a high level research centre in Telugu language, History, Culture, literature and Arts
2. To impart training to those residing within and outside India who study Telugu language, literature and

3. To develop Telugu as a language of modern knowledge and medium of instruction
4. To facilitate national integration through Arts, translations and publication of texts from Telugu into other languages and vice-versa.

1.2 Strength, Weakness, Opportunity and Challenges(SWOC)

Institutional Strength

- Cultural Heritage and Language Promotion: The University has a strong focus on promoting and preserving the Telugu language and culture, making it a unique institution in the region.
- Specialized Academic Programs: Offering specialized courses in Telugu language, literature, fine arts, and culture, which attract students interested in these fields.
- Community Engagement: Strong community outreach programs, including health camps, literacy drives, and environmental awareness initiatives.
- Qualified Faculty: Experienced and dedicated faculty members with expertise in Telugu studies and other disciplines.
- Physical Facility: 100 acres of land at Bachupally Campus
- Unique Departments & Centres: Lexicography, Encyclopedia
- International Affiliations: U.S.A. (SiliconAndhra – Manabadi, Sampada, Suswara Academy), Malaysia (Malaysia Telugu Academy) & Singapore (Swaralaya Arts)
- The University has a very active publication division and an audio visual division which have published classics in Telugu literature and text books etc., and produced documentaries on renowned personalities. The University works towards preservation, propagation, promotion and advancement of Telugu language, literature, art and culture.
- Museum “Telugu through the ages”
- The documentaries produced on stalwarts of Telugu culture by the Audio Video Recording Division.

Institutional Weakness

- Infrastructure Limitations: Some infrastructural facilities may require upgrades to support advanced research and modern educational needs.
- Funding Constraints: Limited financial resources can hinder the expansion of programs, research projects, and community outreach activities.
- Limited Technology Integration: Need for greater integration of technology in teaching, research, and administrative functions to enhance efficiency and learning outcomes.

Institutional Opportunity

- Collaboration and Partnerships: Opportunities to collaborate with national and international institutions for research, cultural exchange, and academic programs.
- Digital Education: Expanding online courses and digital learning platforms to reach a wider audience, especially in the context of Telugu language, culture and fine arts.
- Government Support: Potential to leverage government schemes and grants aimed at promoting regional languages and cultural heritage.

- Alumni Engagement: Engaging alumni to contribute to the university's growth through mentorship, funding, and networking opportunities.
- Cultural Tourism: Promoting cultural tourism by organizing events, festivals, and exhibitions that showcase Telugu culture and attract visitors.

Institutional Challenge

- Technological Advancements: Keeping pace with rapid technological advancements and integrating them into the university's academic and administrative processes.
 - There is always a danger of students opting courses like engineering and allied subjects. Despite this, our University still finds parents and students who are interested in taking-up fine arts, social sciences and humanities as their career.
 - Retention of Talented Faculty: Retaining qualified and experienced faculty members amidst offers from other institutions and private sector opportunities.
 - Student Enrollment Fluctuations: Variability in student enrollment numbers due to changing interests and career trends among potential students.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

The University is offering programmes in U.G, P.G, M.Phil, Ph.D Diploma and Certificate in several subjects. These programmes are spread over 5 campuses at different regions of two States, namely Hyderabad, Warangal, Rajahmundry, Srisailam and Kuchipudi.

Most of the courses designed by the University aim at developing new creative skills to the students so that they can participate in and contribute for the cultural development of the State.

The medium of instruction in the University is predominantly Telugu and this encourages students from the disadvantaged sections to take up higher-level courses.

The University has introduced the following new programmes during the last five years: M.A. History, Culture & Tourism, M.F.A., B.Li.Sc., B. Design, P.G. Diploma in Yoga.

The programmes in Folk & Fine Arts, Linguistics, History, Tourism, Design, Library Science provide an opportunity for the students to hone up their skills. The Programmes in Visual Arts (Painting, Sculpture, Print Making) and Performing Arts (Music, Dance, Theatre and Folk), History Culture and Tourism, B.Li.Sc., B. Design train the students in excellence in the chosen field which makes them self-sufficient.

Recently the University established Skill Development Centre which offers short term programmes of employability nature.

The Dept. of Communication and Journalism play an important role in ensuring social responsibility. This department offers a course titled 'Media Ethics' which deals with standards to be adopted in the field of journalism. Similarly, keeping in view the environment and sustainability, this department offers a course titled 'Environmental Journalism'.

At the graduation level the University introduced a course on ‘Environmental Studies’.

Women issues are dealt in the course work of Socio Linguistics in the Department of Linguistics, The Department of History Culture and Tourism offers a course on ‘Indian Culture’ focusing on the cultural aspects of India.

Teaching-learning and Evaluation

Departments assess the learning levels of the students at the time of commencement of the classes. Depending upon the responses of the students in the class room the department identifies the students into two groups i.e. Advance Learners & Slow Learners. For the slow learners the department conducts revision classes and counseling sessions in addition to the regular teaching classes. The slow learners are also provided separate handouts. Similarly, the advance learners are encouraged to mentor slow learners.

Particularly, the programs offered by this institution i.e. Fine & Performing courses aims to impart practical training to the students.

In the Departments of Performing and Visual arts, (Dance, Theatre, Music, Painting and Sculpture) the practice sessions/practical classes give an indication of the slow learner as against the advanced learner.

The advanced learner is encouraged to perform in front of renowned artistes in their field from time to time (especially during special occasions such as Music Day, Theatre Day etc) so that they will gain knowledge as well as encouragement from them.

Teaching–learning methods adopted by the faculty members include Lecture Method, Interactive Method, Project-based Learning, Computer-assisted Learning, Experiential Learning etc. The Teaching – learning activities are made effective through illustration and special lectures.

This being a university to promote culture and Arts in the main, most of the courses are practical oriented.

While the Fine and Performing Art departments incorporate performances in the curriculum, the Department of Communications and Journalism, the Dept. of Design, Dept. of Yoga imparts practical training.

The Dept. of History, Culture & Tourism organizes field work for their students. The faculty members foster learning environment by engaging in rich experiential content of teaching through experience, Teaching through demonstration, visual aids, Organizing exhibitions, Presenting papers and holding seminars. The Mentor-Mentee system was introduced in the University in the year 2016-17. As part of Mentor-Mentee system each faculty member is allotted 15 students and these mentors will counsel student’s in academic and non-academic issues on regular basis.

The academic performance of students is evaluated through seminars, PPTs, assignments and slip tests. Special classes are arranged for the slow learners and similarly the students are encouraged to participating in group discussions. Students’ feedback on the courses is collected from them. The students are asked to prepare presentations on various topics. Since the courses in this University are seldom impersonal (in performing arts, the teacher and student need to act as a team and personal attention is natural to each student), the relationship exercise in creativity, team-work and mutual co-operation between teacher-student borders on companionship. Hence the evaluation process becomes an exercise in creativity, team-work and mutual co-operation. The

University recently introduced new programmes which aims at developing the skills of the students so as to enable them to fit in the modern competitive world.

Research, Innovations and Extension

Telugu University established main objective of to function as High Level Research Centre in Telugu Language, Literature and Culture. It facilitates and regulates advanced study and research in Art, Culture, Music, Theatre, Painting, Sculpture etc.

The main thrust area of the University is to develop research in the above related subjects. Almost all the departments are engaged in research activities. The University has established Research Advisory Committee to monitor the research activities in the University. Apart from research Advisory Committee, recently in tune with UGC guidelines established Research & Development Cell headed by a senior faculty to strengthen the research activities in the University. The two campuses of the University i.e. Srisailam & Warangal are meant (In addition to P.G. Prgrammes) for research alone in the areas of History, Culture & Archaeology and Tribal & Folklore respectively. All the departments are equipped with departmental libraries and subscribe research journals. The University provides publication grant to M.Phil & Ph.D. thesis to encourage both students and faculty. The Research and Development Cell periodically holds meetings regarding the latest development and guidelines in research as per UGC rules. This cell gives advice to research guides, heads of departments and students whenever necessary regarding the rules and regulations.

The University to encourage research, supports the research scholars financially by sanctioning University Research Fellowships. The University is encouraging the scholars by providing them financial assistance for publishing their research thesis.

The University also provides seed money to the teachers of Warangal campus for carrying out the research.

Infrastructure and Learning Resources

Telugu University has a well maintained campus spread over hundred acres of land at Bachupally and similarly the satellite campus situated at Nampally has three acres of land. The existing infrastructural facilities are utilized both for conducting theory and practical classes in the main and satellite campuses. The following facilities for teaching and learning are available. Classrooms: Compact Class rooms are available for teaching and learning in the University. There are 7 e-class rooms are available in the satellite campus and three e-class rooms in main campus. Srisailam, Rajahmundry, Warangal and Kuchipud campuses are also equipped with e-class rooms. Conference Hall: The University has a seminar hall for conducting Viva-Voces, important meetings and other programmes. All the campuses situated outside Hyderabad are also equipped with Conference Halls. Auditorium: An auditorium with a seating capacity of 250 is available for conducting Music Concerts, Theatre Plays and other Cultural Programmes. Sales Division: A sales division for the sale of books published by the University is available. Museum: 1. A Museum Telugus through the Ages is hosted in the ground floor of the University. It has paintings, sculptures of Telugu luminaries. 2. Antiquities and Artifacts Museum is established at School of History and Archaeology which serves the needs of the researchers. 3. Folk and Triballore Museum is established at School of Folk and Triballore at Warangal campus. Archives: The University houses an Archives where the documentation of Folk and Triballore is preserved at School of Folk and Triballore at Warangal campus. Lab: Lab room is available for the students of History and Archaeology. Art Gallery: The University has an Art Gallery for conducting Art Exhibitions. Language Lab: The University

has a Language Lab for the purpose of students and staff. Library: The Library of the University is located at Bachupally. The Library has a wide and varied range of books on subjects like literature, language, arts, history and social sciences. It has a separate room with computers equipped with internet facility for the use of students and staff. Chitravani Studio: The University has an Audio-Video recording studio for recording, editing with high end equipment. Computer Cell: The University has a Computer Cell, which looks after the maintenance of computers in the University. Graphic Workshop: The University has a Graphic Workshop which facilitates outside artists to work in this workshop to hone-up their skills. The Central Library of the University is equipped with INFLIBNET facility and using SOUL (Software for University Libraries). Data base for English & Telugu books are digitized. Almost all the departments have LCD projectors, overhead projectors, printers and scanners. The computers and printers of all the departments have software installed in them and the Hardware is also maintained from time to time. The website is monitored and updated from time to time by the Computer Cell. The computers and printers of Administrative block and Computer Lab are connected in LAN. The whole campus has Wi-Fi facility. Maintenance and up-gradation is done from time to time. The University is equipped with 1GBPS band width.

Student Support and Progression

The programmes offered in this University are seldom impersonal, the relationship between teacher-student borders on companionship. Hence here the personal counselling plays an important role in guiding the future of the students. During Covid-19 time the University has conducted webinars for the sake of the students and the University has also organised motivational talks of the eminent personalities. The University has also a Placement Cell which offers guidance to the students relating to placements. Students of this institution have facilities like - freeship, scholarships, URF and RGNF fellowships. Students have hostel facility, access to health facility and a multi-faceted library which provides them with material for not only their subjects but for competitive examinations too. Students can approach for redress of grievances through Dean, Students' Affairs, Chief Warden and Wardens of the hostels. There is an Anti-Ragging Cell which monitors activities of students and their relationships helping to prevent ragging in any form. The University has a transparent mechanism to redress grievances of students. With emphasis laid on cultural heritage, the students have actively participated in the cultural, literary and other extension activities. The Alumni of this university consists of great stalwarts and established professional artistes in their respective fields, such as Carnatic Music, Kuchipudi Dance, Television, Cinema, News Media, Folk, and Sculpture. The students regularly take part in various activities of NSS apart from participating in youth festivals.

Governance, Leadership and Management

The organizational structure is decentralized with responsibilities of each department clearly etched. The Vice-Chancellor is the academic head of the University. All the policy decisions will be taken by the Vice-Chancellor with the approval of the Executive Council. The Registrar, as the administration head, oversees the organizational functioning. The Finance Officer is the statutory officer of the University who looks after the financial matters. The hierarchy of both academic and administrative structures such that the Deans and Directors and Officers of the University need to lead from the front and the university takes care that the people in higher positions possess leadership qualities. The Heads of the department co-ordinate and monitor the work of the department under the guidance of the Deans of the respective schools. The Directors of the Centre monitors the work of the Centre. The Research Committee monitors the smooth progress of research work in coordination with the Heads, Directors and Deans. The IQAC coordinates with the Heads, Directors and Deans regarding UGC projects, academic affairs, research etc., to maintain the quality. The Controller of Examination

monitors the examination process. The Central Admission Committee monitors the process of admissions. Telugu University extends the following welfare measures to teaching and non-teaching staff: House Building Loans, Medical Facility –Health Cards, Education Advance, Vehicle Loan, Marriage Advance, Group Insurance Scheme, Special Festival Advance (Non-Teaching Only), Festival Advance, House Building Repairs Advance.

The University receives Block Grant from the State Govt. The Block Grant is for payment of Salaries of the Staff and maintenance of other heads. The Development Grant from RUSA is utilized for the specific purposes. The University has the following internal resources. Rent from Auditorium, Fee generated from Distance Education Courses, Rent from Audio-Video Recording Division, Rent from Art Gallery Donations received from philanthropists, The resources so generated are utilized for conducting festivals, cultural events, honoring scholars etc. To some extent the internal resources are utilized for maintenance of infrastructure and learning resources. The Accounts of the University are audited regularly and the Audit objections are attended by the Internal Audit Officer.

Institutional Values and Best Practices

This University has taken various initiatives for promotion of gender equity. Several awareness programmes on gender equity has been conducted. Seminars / workshops were conducted during the last five year. Generally, the University organises gender equity programmes on particular days i.e. Women's Day and Batukamma Festival. Women's Grievance Cell, Anti Ragging Cell are some of the cells are actively working in the University. The Women were given a separate room for dining and other purposes. Celebrating important days such as International Biodiversity Day, International Water Day, World Environment Day, Vanamahostav Week etc. are among the few activities taken up by the University to create environmental awareness. The University also organised awareness programmes under the banner of Swach Bharat for plastic free campus, clean and green programmes and taking-up plantation and disposal of leaf litter from the harvesting pits. As a part of State Government's prestigious programme, "Haritha Haram", the University planted 300 saplings in the campus. Similarly, the University is discouraging the usage of Plastic bags through circulars and notices. Good greenery is maintained at all the Campuses of the University. In the satellite campus situated in Nampally, the University is equipped with Lifts and Ramps. Since the University shifted to Bachupally campus, though there is a provision for Lifts & Ramps, it may take a few months to install the lifts. Similarly, the Braille software is available for blind students. A wheel chair is provided in the campus for the Divyangjan students. The facility of restrooms for Divyangjan students is available in the campus. Scribes are provided for the blind students to write the exams as per norms. The following national festivals and Birth and Death Anniversaries are organized by the Telugu University: Independence Day, Republic Day, Gandhi Jayanthi, Teachers Day, National Integration Day, National Voters' Day, Babu Jagjivan Ram's Jayanthi etc., Ambedkar Jayanthi, Telangana Formation Day, World Theatre Day, World Folk Day, World Dance Day, World Music Day, International Mothers' Language Day.

1.1.1

Curricula developed and implemented have relevance to the local, regional, national, and global developmental needs, which is reflected in the Programme outcomes (POs), and Course Outcomes(COs) of the Programmes offered by the University

Response:

- The University is offering programmes in U.G, P.G, M.Phil, Ph.D Diploma and Certificate in several subjects. These programmes are spread over 5 campuses at different regions of two States, namely Hyderabad, Warangal, Rajahmundry, Srisailam and Kuchipudi.
- Most of the courses designed by the University aim at developing new creative skills to the students so that they can participate in and contribute for the cultural development of the State.
- The medium of instruction in the University is predominantly Telugu and this encourages students from the disadvantaged sections to take up higher-level courses.
- The staff and students use Performing Arts as a tool to spread messages on various issues of social awareness. These include communal harmony, health and women empowerment.
- The global demand activity is conducted through the International Telugu Centre, an important wing of the University.
- The University is catering to the needs of Telugu students living in other States and abroad by providing text books and other materials.
- It is working in collaboration with Telugu Associations in other countries to provide material for young children to develop their language capabilities. The syllabus and examinations conducted by the University will enable them to take up advanced studies in Telugu at a later stage.
- The programmes in Folk & Fine Arts, Linguistics, History, Tourism, Design, Library Science provide an opportunity for the students to hone up their skills.

Response:

- The programmes in this university are all conducive to self-employment of the student. The curriculum has heavy input of practical training apart from theory which helps them in getting employment in the concerned area.
- It strives to achieve a balance between the uniqueness of its courses and the existing market needs. Hence, the curriculum is so designed that the students are equipped to get employment

sustainability, this department offers a course titled ‘Environmental Journalism’.

- At the graduation level the University introduced a course on ‘Environmental Studies’.
- Women issues are dealt in the course work of Socio Linguistics in the Department of Linguistics,
- The Department of History Culture and Tourism offers a course on ‘Indian Culture’ focusing on the cultural aspects of India.
- The Fine Arts and Performing Arts are self-conducive by themselves in promoting and propagating human values and sensitivities. The courses in Fine Arts and Performing Arts actively motivate in creating awareness.
- The Department of Folk Arts trains its students to use folk art forms in spreading social message (child labour, gender sensitization) in remote areas of the state.

2.2 Catering to Student Diversity**2.2.1**

The institution assesses the learning levels of the students and organises special Programmes to cater to differential learning needs of the student

Response:

Departments assess the learning levels of the students at the time of commencement of the classes. Depending upon the responses of the students in the class room the department identifies the students into two groups i.e. Advance Learners & Slow Learners. For the slow learners the department conducts revision classes and counseling sessions in addition to the regular teaching classes. The slow learners are also provided separate handouts. Similarly, the advance learners are encouraged to mentor slow learners. Particularly, the programs offered by this institution i.e. Fine & Performing courses aims to impart practical training to the students.

- In the Departments of Performing and Visual arts, (Dance, Theatre, Music, Painting and Sculpture) the practice sessions/practical classes give an indication of the slow learner as against the advanced learner.
- The advanced learner is encouraged to perform in front of renowned artistes in their field from time to time (especially during special occasions such as Music Day, Theatre Day etc) so that they will gain knowledge as well as encouragement from them.

Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experience and teachers use ICT- enabled tools including online resources for effective teaching and learning process

Response:

Teaching–learning methods adopted by the faculty members include Lecture Method, Interactive Method, Project-based Learning, Computer-assisted Learning, Experiential Learning etc. The Teaching – learning activities are made effective through illustration and special lectures.

Eighty percent of the courses focus on experiential learning including practical and work experience. The curriculum equips the students to achieve self-sustainability through developing their talents.

The creative talent of the students is encouraged in these practical classes; for instance, the Department of Theatre Arts includes in its curriculum a unit for the students to write, produce and direct stage plays and Television plays. This gives them hand-on experience in the field.

The students are also encouraged to participate in the cultural activities conducted by the University on different occasions. Thus paving way for them to hone-up their skills.

This being a university to promote culture and Arts in the main, most of the courses are practical oriented.

While the Fine and Performing Art departments incorporate performances in the curriculum, the Department of Communications and Journalism, the Dept. of Design, Dept. of Yoga imparts practical training.

The Dept. of History, Culture & Tourism organizes field work for their students.

The faculty members foster learning environment by engaging in rich experiential content of teaching through experience, Teaching through demonstration, visual aids, Organizing exhibitions, Presenting papers and holding seminars.

Centre for Preparation of Encyclopaedia: This centre prepares encyclopaedias of all branches of human knowledge through Indian language, Telugu.

Publication Division: Publication division publishes Telugu classics, rare books, dictionaries, books on social concerns etc. It brings out the Telugu translations of the complete works and speeches of Dr. B.R. Ambedkar.

Extension Services Division: This University is a confluence of various erstwhile academies and the activities of these institutions are carried out by this division. ESD extends financial assistance to writers for publishing their works, besides honouring the scholars.

International Telugu Centre: The University caters to the needs of Telugu students living in other States and abroad by providing text books and other materials. It works in collaboration with Telugu Associations in other countries to provide material for young children to develop their language capabilities. The syllabus and examinations conducted by the university will enable them to take up advanced studies in Telugu at a later stage. Foreign students interested in learning Telugu are provided a platform in the form of diploma and certificate courses and training camps. Schools from other States follow the syllabus and textbooks prepared by the Telugu University in teaching Telugu as Second and Third Language. ITC conducts World Telugu Conferences in and outside the country, also organizing National Conferences of repute.

Concluding Remarks :

University functions in accordance with the provisions of the Act. It has a well defined organisational structure and the responsibilities are decentralised paving way for transparency both in academic and administration. Aims and objectives of the University are carried out through teaching, research, publication and extension activities. The unique feature of this University to provide higher education in mother tongue i.e. Telugu. The medium of instruction in the disciplines like Linguistics, History, Journalism, Jyothisham is Telugu. University focuses at cultural integration through various performing arts like Dance, Music, Theatre and Fine Arts. These disciplines hitherto have been more accessible to the elite. The University offers these courses to the students at grass root level to bring out the inherent talent hidden in them which provides self-sustenance. The SCs, STs, OBCs and women form approximately 80% of the total student population of the University. As the University is unconventional in nature, it strives to achieve a balance between the uniqueness of its courses and the existing market needs. Most of the courses in performing arts and fine arts are practical oriented, while the Department of Communication and Journalism gives practical training in print and electronic media. The curriculum is so designed which helps the students in skill development, employability and entrepreneurship.
